Booth Sizes: Booth sizes are 10x10

Booth Fees: \$ 20.00 for a 10x10 space
\$ 30.00 for a 10x20 space
\$ 40.00 for a 10x30 space

Rules & Regulations:

1. The City of St. Charles and the Winona County Fairgrounds, it's agents, employees and affiliates assume no risk and shall not be responsible for any damage, injury, loss, legal action or expenses that may arise or come to the vendor or their employees, their goods, property or to the public from any cause whatsoever. The vendor understands that they should carry business/personal liability insurance.
2. The committee reserves the right to cancel any or all future reservations made by a vendor acting in any manner deemed to be inappropriate.
3. Vendors must be present and set up during all hours open to the public. Please be set up by 9:00 am on Saturday. NO EARLY tear downs, unless pre-approved by the coordinator. This is a rain or shine event.
4. **NO REFUNDS** for cancellations after August 10th, 2016. **All booth fees MUST be paid in advance, no paying on day of the show. No exceptions.**
5. **Inside spaces fill up quickly, and many vendors re-book for the next year, so please send payment early to be guaranteed a space. You MUST be there BOTH days of the show, no ONE day bookings will be accepted.**
6. **Outside electricity is limited, and only available in certain areas, if you need electricity, I MUST know to plan your space around the outlets. If you do not absolutely need electricity, please save the spaces for the ones who do. Must supply your own extension cords.**
7. Spaces will be marked by last name prior to set up.
8. Vendors must bring all canopies, tables, chairs & display materials. Table covers are required.
