**ST. CHARLES PARK & RECREATION**  
**Co-Rec Volleyball Rules & Regulations**

1. Coin flip will determine the serving team for the first & third games.
2. Roster is due after your first game. Any additions or deletions after the first game must be done at the Park/Rec Office.
3. Teams will play 3 games to 25 points (must win by two). Scoring will be the rally point system. Each game counts as one point in the standings.
4. A team consists of 6 players, 3 of which should be female & 3 male. You may play with more women than men but not more men than women. You must have 4 players to play, 1 must be male.
5. Substitutions must come in for the server, & the substitute must play a complete rotation.
6. GRACE PERIOD (see key below \*\*\*)
7. Any player ejected from any contest will be gone for the remainder of the year.
8. Only players listed on the teams roster will be allowed to participate.
9. Players must be out of high school to participate.
10. Game protests must be filed with the opposing team manager & the scorekeeper before, during or up to 24 hours after the match. The Park/Rec Director will rule on the protest as soon as possible. A reminder, you cannot protest judgement calls.
11. Each team is allowed 2 time-outs per game. (45 seconds)
12. When a ball is contacted by more than one player on a team, one of the contacts must be by a women.
13. Men & women must be positioned alternately on the court.
14. No back court player can attack offensively ahead of the 10 ft line. It is permissible to play ahead of the 10 ft line.
15. Game Equipment:
  - A) Net height is 8 ft
  - B) Game balls are provided (teams must supply own practice balls)
16. Let serves & setting a serve are permitted.
17. Other than our league rules, games will be governed by Minnesota State High School League Volleyball Rules.

- \*\*\* **1st Game** = Must start on time/or when scorekeeper starts match if behind schedule. If a team cannot field a team at this time they will forfeit the first game.
- 2nd Game** = A team will have 5 minutes to field a team. If they cannot field a team at this point, they will forfeit the second game.
- 3rd Game** = A team will have 5 additional minutes to field a team. If they cannot, they will forfeit the third game also.
