With this information and current trends for home sales Mr. Conway lowered the assessed values of more expensive homes slightly, and older homes remained near their value of the current year.

While the service is subsidized by MnDOT, a local match must still be made to operate the service. He intends on asking all communities that are served by the system to provide financial support in the future.

City of St. Charles Resolution #12-2024

A Resolution Approving A Seven-Day County Fair Temporary On-Sale Intoxicating Liquor License

WHEREAS, the Winona County Agricultural & Industrial Fair Association is submitting an application to the City of St. Charles in order to sell Intoxicating Liquor at the Winona County Fairgrounds on Wednesday, Thursday, Friday, Saturday and Sunday July 10-14, 2024.

WHEREAS, the entire perimeter of the site not on the side of the grandstands must be enclosed by a row of safety fencing, each row at least 4 feet in height. If Lessee wishes to use a barrier other than safety fencing, alternative materials with similar safety qualities may be pre-approved by the City; and

WHEREAS, the entire licensed site must be closely monitored by the licensee to ensure that no one leaves the premises with an alcoholic beverage in hand and/or passes such a beverage to anyone off the site; and

NOW THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ST. CHARLES, MINNESOTA that:

1. The Council of the City of St. Charles hereby approves the Temporary On-Sale Intoxicating Liquor License submitted by the Winona County Agricultural & Industrial Fair Association to the City of St. Charles.

March 2024 Public Works Report:

Street Department

Maintenance at City Hall and library, chairs back and forth to library for the book reading; crack filling; sweeping streets; cleaning catch basins; repair culvert pipe (24"); dirt and seed around town; maintenance on bucket truck and digger truck; cut trees and brush in waterways and dry ponds; assisted the Water Department in flushing hydrants; assisted the Electric Department with setting basements, pedestals, and street light poles; and removed the plow wings off trucks.

Electric Department

Daily routine of checking wells, pump houses, towers, and lift stations; daily finals and re-reads; replaced meters that weren't working or picking up; sanded hills and plowed; located and mapped curb stops; hauled compost; picked up black dirt and hauled to shop (four loads); picked up sand and hauled to shop (two loads); flushing hydrants; working on hydrants; reading meters, hand out disconnect slips; collected water samples and performed testing.

Water Department

Rubber gloves, sleeves, and hoses were sent in for testing; take down security lights around town (people didn't want them anymore); running monthly testing of generators and power plant; daily locates; inventory; installing secondary pedestal and basements; dirt and seed for 2024 underground project; working on new hook ups and installs of new underground; power outages on East 14th street and East 8th street; install new light poles and lights; replaced three bad wood poles with new ones and transferred everything back over; attended generator school; working with Border States on Bi-Directional Meters and reprogram them.

All departments are working great together for the many tasks at hand, and the different tasks that seem to be ever changing!




- -Attached you will find reports for the month of April 2024. The St. Charles crew handled 28 incidents for the month and made contact with 28 patients. Lewiston Ambulance responded to 1 incident with SC for a vehicle crash with multiple patients. The monthly incident report is included that shows the dispatch reasons. Additional reports in the packet show the "on-call" schedule for the month of April along with a breakdown of "call hours" each member provided. 30 days x 24 hours of coverage= 720 hours x2 crew members=1,440 required hours. SC was staffed 100% of the month. I included the monthly schedule which shows you how we are utilizing paid staff and volunteers. You can also see how the addition of the 6 new EMT's has helped with scheduling. The next challenge will be getting through the summer months which are historically more difficult to cover. I have included an updated membership roster in the packet.
- -Madison Arndt has resigned from the service effective 5/1/24 as she is moving to Iowa to continue her education to become a doctor. We thank Madison for her service to the community over the last 2 years!
- -We conducted volunteer interviews on 4/11 and have hired 3 new members. Sean Conklin, Daniel Kramer, and Abbi Stafslien-Dumale. All 3 of these recruits have been in our ride along program and already have their EMT certification. They will come on our schedule in May and begin our internal training.
- -We hired a new part-time EMT to fill the vacancy left by Jacob Smith who is now the full-time employee. Rachel Russell was hired for this position and will work up to 20 hours per week along with the other part-time employee Katie Kramer. Their working days will vary but will be focused on the days of Friday-Monday from 8am-6pm. Rachel obtained her EMT certification in January of 2024 and will spend the next few months training with other members. She will be a great addition to the team!
- -Members will have multiple options to train during the month of May with joint trainings being held in SC & Lewiston along with our monthly in-service training on 5/8/24.
- -A committee was established to plan our annual EMS Week open house event. The event will be held on Saturday May 18th from 1pm-3pm at the Station. This will be a "touch a truck" event along with root beer floats.
- -Members Boice & Schossow can provide any Steering Committee updates as needed.



City of St. Charles Resolution #13-2024

A RESOLUTION ADOPTING FINDINGS OF FACT AND REASONS FOR DENIAL FOR VARIANCE APPLICATION FOR 306 ST. CHARLES AVENUE

FACTS

- 1. Mitchel & Stephanie Holliday are the owners of a parcel of land located at 306 St. Charles Avenue, St. Charles, MN; and,
- 2. Mr. Holliday has applied to the City for a variance to a fence.
- 3. The proposal would vary from ordinance 152.42(E)(7)(a)5 in that it would reduce the setback on a double frontage lot to build a six foot fence along the property line.
- 4. Following a public hearing on the application, the St. Charles Planning Commission has recommended denial of the variance on May 9, 2024.
- 5. The City Council of the City of St. Charles reviewed the requested variance at its meeting on May 14, 2024.

APPLICABLE LAW

- 6. Minnesota Statute Section 462.357, subd. 6 provides:
 - a. Variances shall only be permitted (a) when they are in harmony with the general purposes and intent of the ordinance and (b) when the variances are consistent with the comprehensive plan.
 - b. Variances may be granted when the applicant for the variance establishes that there are practical difficulties in complying with the zoning ordinance. "Practical difficulties," as used in connection with the granting of a variance, means that (a) the property owner proposes to use the property in a reasonable manner not permitted by the zoning ordinance; (b) the plight of the landowner is due to circumstances unique to the property not created by the landowner; and (c) the variance, if granted, will not alter the essential character of the locality.
- 7. City Ordinance requires that processes found in ordinance 152.46 Variances be followed.

CONCLUSIONS OF LAW

- 8. The requested variance is not in harmony with the purposes and intent of the ordinance because it intensifies the permitted standards of the ordinance.
- 9. The property owner does not propose to use the property in a reasonable manner. Fences are currently allowed within the front yard setback at a maximum of 48" with certain conditions. The property can still be put to reasonable use without the proposed variance.
- 10. There are no unique circumstances to the property not created by the landowner.
- 11. The variance will not maintain the essential character of the locality because it deviates from the ordinance that was approved in 2015, as well as fences that have been erected since that time.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF ST. CHARLES, MINNESOTA AS FOLLOWS:

The application to issue a variance to allow Mitchel & Stephanie Holliday to build a six foot fence in the required front yard setback so as to deviate from ordinance which states "no fence, wall, accessory structure or shrub planting shall be over 36 inches in height with an opacity over 50%, but may be 48 inches in height with an opacity under 50% (e.g., wrought iron, chain link, split-rail, vinyl, or board), within 25 feet of the front property line" is hereby denied.
